What does 3C certification mean for power banks?

3C certification, short for China Compulsory Certification, is a legal safety requirement for electronics sold or used in China—including power banks. Since 2025, any power bank without a 3C mark is banned from domestic flights and retail shelves. This isn't just a formality.

Can I bring a 3C power bank on a train?

Trains have outlets, but power flow can be unstable. So having a safe, certified 3C power bank is your best bet for charging on the go. Q: Can I bring more than one 3C power bank when flying in China?

A: Yes, but there's a limit. You can bring up to two power banks between 100–160Wh with airline approval. Under 100Wh?

Are 3C power banks safe?

Power banks without a verified 3C mark fail to meet China's mandatory safety standards. Forget flashy packaging or good reviews—check the label and match it with the CNCA official database before buying. What Safety Standards Power a 3C Power Bank?

What happens if a power bank doesn't have a 3C Mark?

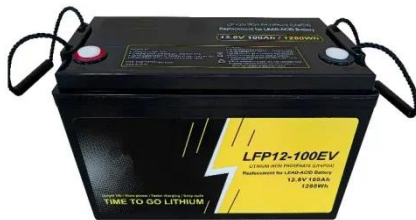
