# Energy storage project restrictions



## Overview

---

Are solar and storage projects eligible for tax credits?

To be eligible for tax credits, materials from a prohibited foreign entity (PFE) must be under a certain percentage threshold. These thresholds are different for solar and storage projects and increase annually:.

Are solar and energy storage developers facing a complex landscape?

With the budget bill passed and new Section 232 polysilicon and AD/CVD cases making headlines, solar and energy storage developers and equipment buyers are facing an increasingly complex landscape.

What is the threshold for a power project?

The fraction must be at least 40% for power projects on which construction starts in 2026, increasing over time, to 60%, for projects starting construction after 2029. The thresholds are different for storage projects.

When does a solar project qualify for a tax credit?

Currently, solar projects must be placed in service by the end of 2027 to qualify for the tax credit. There's an exception for projects that start construction within one year of bill passage (by J), enabling those projects to get 100% ITC if placed in service within 4 years.

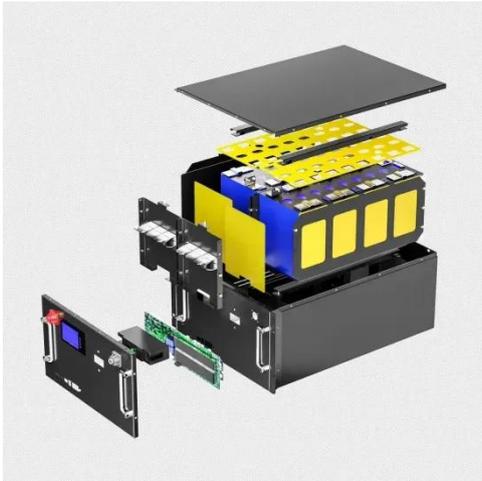


