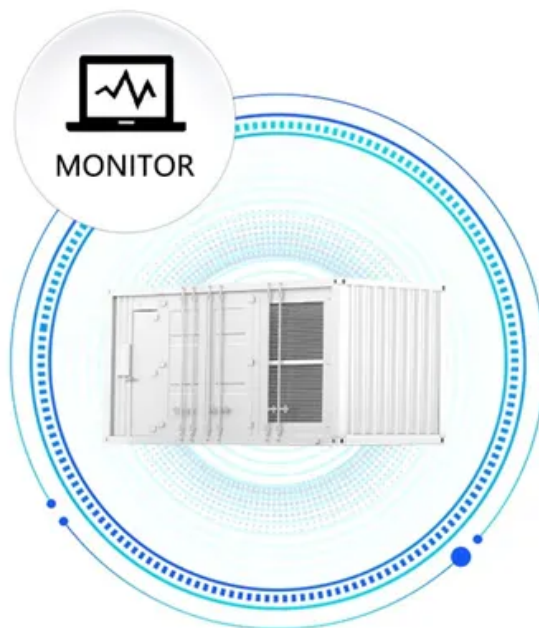

What is a third-party energy storage system?

Third-party ownership involves a company like Madison Energy Investments financing and operating the battery while the savings are shared between the energy storage system owner and the host site. This option eliminates the upfront capital requirements and the need for system operation staff for the host site.

Is a hybrid battery energy storage system a viable option?

A hybrid model, combining aspects of both structures, offers shorter-term agreements but may be less cost-effective. Barrague highlighted different geographic markets where battery energy storage projects are financially viable.
