Overview

Can solar PV products be imported into Zambia?

Solar PV Importation Procedures Section 32 (1) of the Customs and Excise Act, Chapter 322 of the Laws of Zambia, provides that goods shall not be imported into Zambia without an entry and declaration being made and without such duties as may be imposed by law being paid or secured.

Are solar panels tax deductible in Zambia?

In 1999, the substantive customs duty rate on solar panels was removed. The primary legal basis for further energy access fiscal incentives in Zambia are the Customs and Excise (Electrical Machinery and Equipment) (Suspension) Regulations, 2008 and the Value Added Tax Act (Zero-Rating).

What is a solar PV customs Handbook?

This Customs Handbook provides comprehensive guidance to stakeholders on the process of importing Solar PV products. Further, the Customs Handbook seeks to clarify the tax and duty exemptions for a range of Solar PV products being sold in Zambia. This will minimize varying interpretations and misapplication of tax exemptions by stakeholders.

Where can I find tariff information in Zambia?

Consult the U.S. Department of Commerce Customs Info Database tariff look-up tool, available on trade.gov (free registration required), to estimate duties and taxes; and the Zambia Revenue Authority's website for the most current information.
