Overview

How many lithium ion batteries can a passenger carry?

In general, most airlines allow each passenger to carry a maximum of two lithium-ion power banks of 100-160 Watt-hour (Wh) into the cabin. However, most power banks on the market use the unit milliamperes per hour (mAh) to measure the battery's capacity. So, look for ones that are no more than about 43,000 mAh to comply with most airline rules.

How many watts can a power bank carry on a plane?

The International Air Transport Association (IATA) already has guidelines in place for lithium battery devices, including power banks. According to these regulations, power banks should not exceed 100 Wh (Watt-hours) for carry-on baggage.

What watt-hour batteries are allowed on a plane?

Batteries with a watt-hour rating over 100Wh require airline approval before carriage. Those above 160Wh are generally prohibited on passenger aircraft. Quantity limits apply: usually up to two spare batteries above 100Wh per passenger, but airline policies may vary.

Can You charge a battery on a plane?

Cathay Pacific and low-cost affiliate HKExpress this month banned passengers from using or charging portable batteries while in flight, or charging them through aircraft power outlets. Passengers are allowed to bring lithium battery-powered devices onboard in carry-on luggage, but they cannot be stored in overhead lockers.


