Hence, the additional US tariffs will have no further impact on Malaysia's solar manufacturing industry," he said. The US reportedly imposed a blanket 9% tariff on solar cell imports from Malaysia — which supplies 14% of its solar cell imports — on Oct 1 last year, singling out five companies for duties ranging between 3.4% and 123.94%.

How has Malaysia impacted the solar industry?

On the Malaysian economy, the extent of the impact remains to be seen. The RM12.5 billion solar PV export figure in 2024 represents 2.08% of Malaysia's total RM601.2 billion in electrical and electronics exports last year, although a number of manufacturers were enjoying tax holidays as investment incentives.




