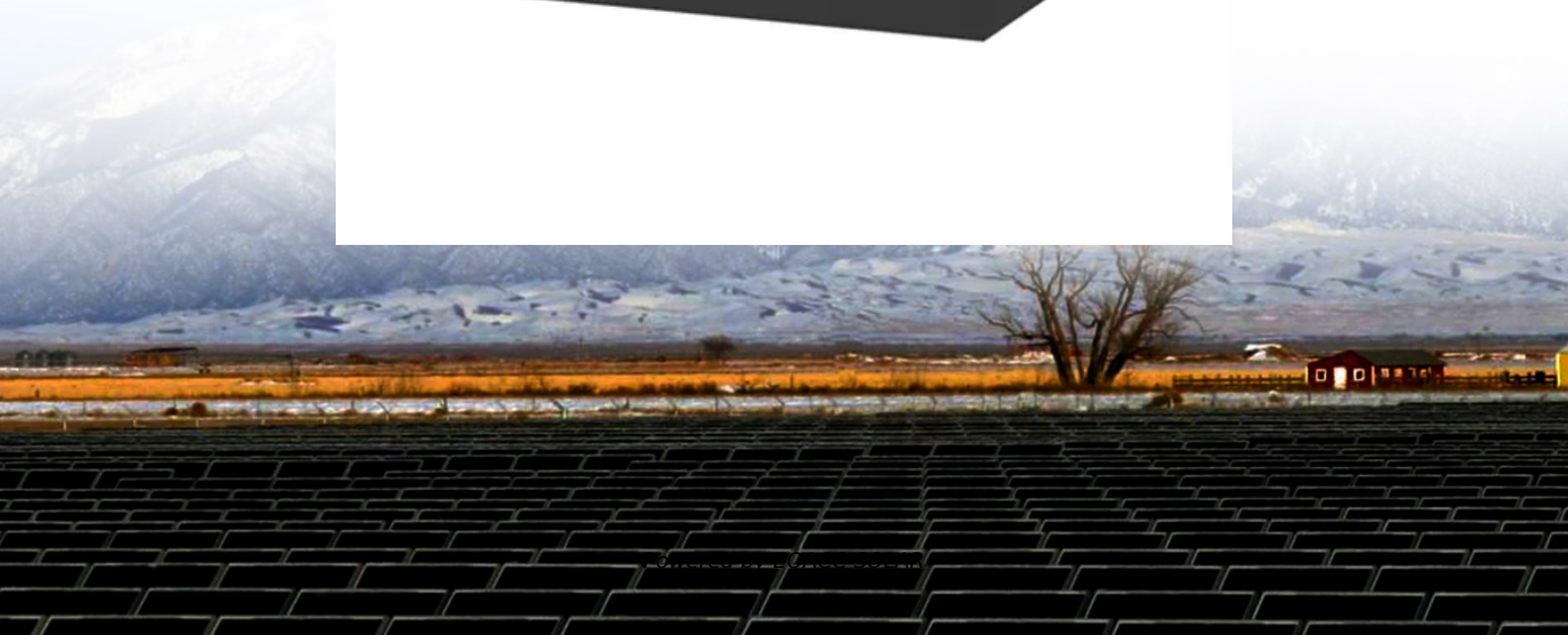

What are the legislative solutions for cable pooling in Poland?

Some legislative solutions, such as amendments to the existing cable pooling regulations, are linked with the Polish National Recovery and Resilience Plan (reform G1.2.2 “Removal of barriers to the integration of renewable energy sources into electricity grids”).

How will Poland's new grid connection agreement affect DSOs & TSOs?

The amendment also introduces a new type of grid connection agreement designed to address the limited capacity of Poland’s infrastructure. Under the proposed rules, DSOs and TSOs will be able to offer flexible connection agreements in areas where the grid is currently constrained.

What does uc84 mean for grid connection?

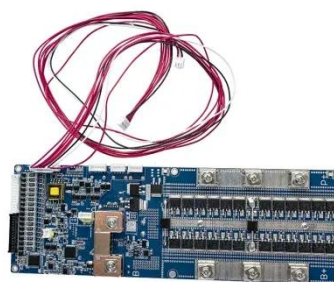
