The next round of tax-free import quotas is set at \$1.014 billion from July 2024 to June 2025 and may be exhausted quickly.

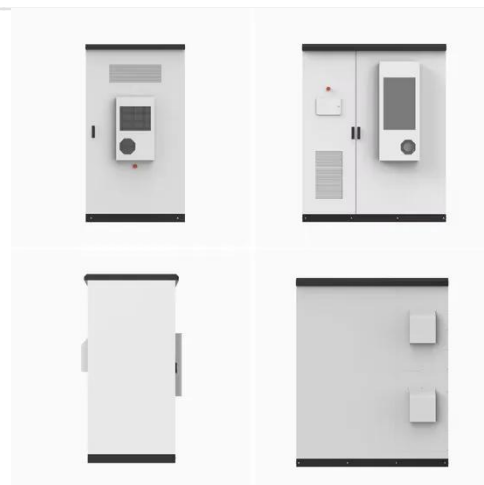

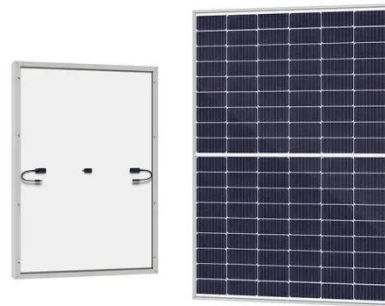
