Will China reduce the export tax rebate for solar panels?

The Chinese Ministry of Finance and the State Administration of Taxation have revealed that the country will reduce the export tax rebate for 209 products, including solar PV cells and modules from 13% to 9%, starting from Decem.

Will Chinese solar panels get a 9 percent tax back?

Chinese manufacturers of solar panels can now only get 9 percent of this tax back. "The remaining 9 percent will also be lost in the first half of 2025," says Scheper. Are solar panels subject to 301 tariffs?

Imported solar energy resources, including solar polysilicon, wafers, and cells from China are now subject to 60% tariffs under Section 301. In May 2024, the Biden administration doubled tariffs on solar cells from China from 25% to 50%.

Why is China reducing solar export tax exemptions?

In 2012, China introduced a new export tax policy aimed at reforming incentives for manufacturers, including the solar industry. In 2012, however, the government began gradually reducing these exemptions to bring them into line with international trade standards and to address concerns about unfair trade practices


