# **Transaction Terms for a 50kW Folding Container**



## Overview

---

The Incoterms rules or International Commercial Terms are a series of pre-defined commercial terms published by the International Chamber of Commerce (ICC) that are widely used in International comm.

What is a full container load (FCL)?

Most freight shipments use containers, or pallets, crates, and boxes that fit into containers or airplane hold. There are seven incoterms dedicated to this type of cargo. A full container load (FCL) is where the shipment is to be the only one in a container.

What is a multimodal Incoterm for container shipping by ocean freight?

The ICC recommends using the multimodal Incoterms for container shipping by ocean freight to avoid miscommunication: FOB – Free on Board: the cargo has to be cleared for export and be ready for transport on board the selected vessel or ship.

What are container specifications & global cargo transportation options (FCL/LCL)?

Understanding container specifications (TEU/FEU) and global cargo transportation options (FCL/LCL) allows businesses to optimize their cargo space and reduce expenses. An international shipping company may quote different rates based on how efficiently you can utilize container space.

What is a full container load?

A full container load (FCL) is where the shipment is to be the only one in a container. Smaller ocean freight shipments, that will be consolidated with other shipments in a container, are called less than a container load (LCL). 
